**Benjamin Antonio Gutierrez Espinoza** is an Associate Director in Delta's construction services practice, bringing deep experience in project controls, forensic planning, and schedule and delay analysis across major infrastructure and commercial projects worldwide. A civil engineer and certified Project Management Professional, Benjamin has supported expert witnesses in complex international arbitration and UK adjudication matters involving large-scale rail, energy and commercial developments. His work spans critical path analysis, programme and records evaluation, and the application of established delay methodologies under FIDIC, JCT, and NEC contracts. Benjamin's background also includes significant on-site project delivery experience in Peru, where he oversaw project controls for government-led infrastructure programmes involving roadways, pipelines, water treatment facilities, and sports venues.

Benjamin's technical expertise is complemented by his strong analytical, communication, and advisory skills. He has conducted detailed forensic delay assessments, prepared expert report inputs, developed programme quality analyses using tools such as Primavera P6 and Deltek Acumen Fuse, and supported experts through joint statement processes and cross-examination preparation. An accomplished researcher and presenter, Benjamin has published and delivered conference work on NEC contracts and challenges in public infrastructure projects.
